Preface



It uses various statistical tools such as compound growth rates, regression analysis, principal component analysis, and the construction of a composite index of agrarian crisis to present a robust, data-backed understanding of the situation. The research also considers the impact of international trade agreements, specifically WTO's Agreement on Agriculture, which exposed Indian farmers to unfair competition from heavily subsidized agricultural products from developed countries.

This book also outlines the limited efficacy of various policy measures implemented by the Indian government, such as the National Agriculture Policy, Pradhan Mantri Fasal Bima Yojana, and others, and suggests that while these initiatives may have offered short-term relief, they have failed to address the deeper structural causes of distress. The conclusions drawn from this study are not only important for academic discourse but also carry significant implications for policy formulation and future interventions.

Ultimately, this work is a contribution to the ongoing dialogue around India's agricultural transformation. It aims to inform scholars, researchers, policy analysts, and decision-makers by providing an integrated view of the agrarian crisis—one that combines statistical evidence, historical context, and ground realities. The goal is not merely to document the crisis but to move toward constructive and inclusive solutions that can restore dignity, sustainability, and profitability to Indian agriculture.
